

Cookies Policy

1. Introduction

This Cookies Policy explains how we, along with our authorized service providers, use cookies, web beacons, and similar technologies when you visit or interact with our websites or services. These technologies help us provide a better, faster, and safer experience and allow us to use the data for advertising and analytics purposes. We have implemented security measures to protect cookie data from unauthorized access, ensuring only us and our authorized service providers can access it.

2. What are Cookies?

Cookies are small text files stored on your device when you visit a website. They contain data that is unique to each visitor and website, allowing the server to tailor content to you specifically. Cookies facilitate smooth transitions between pages, preserve your preferences, and track your usage across sessions or related websites.

Cookies can be categorized as either "persistent" or "session" cookies:

- **Persistent cookies** remain on your browser until their set expiration date or until you delete them.
- Session cookies expire when you close your browser.

Cookies usually do not contain personally identifiable information, but data we store about you may be linked to the information stored in cookies.

3. Types of Cookies Used

We use both first-party and third-party cookies on our websites:

- First-party cookies are set and controlled by us. These include:
 - Storing visitor preferences
 - o Collecting analytics data (e.g., user behavior)
- Third-party cookies are set by external organizations we partner with. These include:
 - o **Google Analytics**: This service tracks how long you spend on our site and which pages you visit, allowing us to improve the user experience. For more information, visit the Google Analytics page.
 - Social Media Cookies: We use plugins from Facebook, Twitter, LinkedIn, and Instagram that allow you to connect with your social media accounts. These cookies may contribute to your profile on those sites and are subject to the respective platform's privacy policies.

4. How We Use Cookies

We use cookies for the following purposes: Strictly Necessary Cookies are essential for the performance of our websites, ensuring they function correctly. Performance and Functionality Cookies recognize you when you return, remembering your preferences and settings. Analytical or Customization Cookies track how users access and move through the website, helping us make improvements. Advertising Cookies personalize the advertisements displayed on our site, making them more relevant to you.



5. Managing Cookies

You have full control over your cookie preferences:

• **Browser Settings**: You can manage or delete cookies by adjusting the settings in your browser. This includes blocking cookies, clearing browsing history, or managing site-specific cookies. However, blocking cookies may affect the functionality of our website, and some features may not work properly.
